

AGENDA

A. Minutes

The approval of the minutes will be performed when a quorum is present.

B. Director's Report

Bill Wyatt, Executive Director, updated the Airport Advisory Board regarding current events.

Mr. Wyatt introduced today's presentation. Medardo Gomez is the airport's new ORAT Director. Mr. Gomez will be providing insight into the new airport and what it will take to get the airport functioning in its new space.

Mr. Wyatt provided an update on the acquisition of the security checkpoint equipment. By law it is a responsibility of Congress, but Congress has not appropriated sufficient funds. The SLCIA team has spent a lot of time evaluating the process with trips to both ATL and LAS to observe their processes.

Mr. Wyatt reported there is still significant growth in passenger volume. The security lines in terminal two are typically long. Kudos to the TSA and their staff for getting people through security and to their airplanes.

Steve Price arrived at 8:07 a.m.

J.T. Martin arrived at 8:08 a.m.

Mr. Wyatt reported the initial airport budget was approved by City Council. It will be formally approved along with the rest of the City's proposed budget by the end of June. The team is continuing to take a deep dive into the construction project budget. Passenger growth is having an impact on the project because it just couldn't be anticipated ten years ago when the project was being developed. A budget refresh will be presented to the board later this year.

Mr. Wyatt encouraged the board to consider taking a tour of the construction site next month. The plaza area would be devoid by that time of any scaffolding and the main plaza, post security is basically done. The roadway is being paved. The ticket lobbies are almost in the final stage. The board could also see the new offices and board room.

Mr. Wyatt also encouraged the board to hold the August meeting at the new Airport Operations Center (AOC.) SLCDA chose to rehab an existing building and it has turned out quite nicely. The TSA strong supports operation centers to be separate from the airport's main offices.

Kudos to Police Chief Brown and his team for being so open and learning as much as they can about the airport during the merging of the two police departments.

Mr. Pinnock asked who is responsible for the lobbying efforts for the TSA funding for the new scanning equipment? Is it something we can take a more active roll in?

Mr. Wyatt answered SLCDA is very involved. There are several employees who are members of the Airport Council International (ACI) and the American Association of Airport Executives (AAAE). The federal budget is under tremendous pressure and airports and airlines are going to continue to bear more direct financial responsibility for these kinds of activities. Airlines would say that they already are because they pay a substantial series of taxes to the federal government.

Ms. Miller clarified the next two meeting dates. June 19th the Board will meet and then tour the ARP. August 7th the Board will tour the Airport Operations Center.

The Board discussed the competitive trade market. There are several large jobs in the valley and contractors are struggling to keep trade workers on the project. SLCIA currently has over ten openings in the Maintenance Department.

C. Minutes

The motion was made by Larry Pinnock and seconded by Jim Riding to approve the minutes of April 17, 2019 as presented. All votes were affirmative; motion passed.

D. Airport Redevelopment Program (ARP) Update – Mike Williams, ARP Director, SLCDA

Mike Williams, Airport Redevelopment Program (ARP) Director, presented an update on the ARP (presentation on file). Main points included were:

Mr. Wyatt added a comment about the upcoming tariffs. The new tariffs will have very little impact on the current work being done because those materials have all been purchased. There could be substantial impact on Phase 2 materials.

Pete Higgins, Director of Airport Operations and Medardo Gomez, ORAT Director, presented the Airport's progress on Considerations for the New SLC (presentation on file). Main points included were:

- Taxiways/ Airside Parking


Mayor Biskupski inquired to the collaboration with the ADA Commission to ensure ADA practices are in consideration for the new airport.


Mr. Higgins indicated he would follow-up with his team and ensure someone reaches out to the ADA Commission.





- (6) **Traffic Signal at XBAR Road** The bid opening for this project was held on March 7, 2019. The apparent low bidder is Cache Valley Electric. Contract documents have been executed. A construction notice to proceed is anticipated for August 2019 due to long lead time on steel delivery.
- (7) **Asphalt Overlay Program 2019 -** The bid opening for this project was held on March 14, 2019. The apparent low bidder is Kilgore Contracting. Contract documents have been executed. A construction notice to proceed is anticipated for the week of June 17, 2019.

CONSTRUCTION

TSA can't afford security machines for new airport, so Salt Lake City and airlines will cover the \$10M to \$15M bill

The project to rebuild Salt Lake City International Airport has flown into a significant problem with the Transportation Security Administration: The federal agency says it can't afford the new X-ray screening machines for carry-on luggage needed at new security checkpoints.

"TSA is obligated to provide these things, but they don't have the resources," airport Executive Director Bill Wyatt said Wednesday at a meeting of the Airport Advisory Board.

So the airport and airlines figure they must come up with \$10 million to \$15 million to buy the machines to ensure that the first phase of the \$3.6 billion airport rebuilding project is able to open as scheduled on Sept. 15, 2020.

Ironically, the airport then must present the machines as a gift to the federal government.

"TSA has to own the equipment," Wyatt said, "so we buy it and then we gift it to them — along with a maintenance contract."

Simply moving and reusing existing equipment is not an option, Wyatt said.

"It is old and cannot be moved," he said, at least not overnight. The switch from the old to new airport is planned to happen literally overnight. A few magnetometers used to screen people might be moved but not the larger X-ray machines for carry-on bags.

Also, the new airport's design counts on using newer high-tech systems designed to speed people through security faster than current machines allow.

At the airport now, people line up single-file to empty pockets and put belongings in gray bins. They push them to the X-ray machine and grab them on the other side and stack bins. If problems occur, officers often ask aloud who owns the problematic bag — and sorting out issues can back up the flow.

Wyatt said the airport plans to switch to a system similar to one now used in Las Vegas and a few other airports.

There, numerous travelers at the same time step up to separate compartments where they place belongings into individual bins that are 25 percent larger and are equipped with radio frequency chips. A conveyor automatically takes them into an X-ray machine.

Bins with materials deemed safe receive a green light and roll to the pickup area (where machines automatically send bins back to staging areas). Bins with suspect items are diverted automatically to a separate area for TSA inspection. Such systems are estimated to process passengers 20% to 30% more quickly.

"We need 22 of these setups for the new airport," Wyatt said. While he's not happy that the airport and airlines will be paying for them, he said the bright side is the new systems "are state of the art. I think the passenger experience will be vastly improved."

Wyatt adds that the airport held meetings with Delta Air Lines — which operates more than 70% of flights in Salt Lake City, and pays the bulk of user fees that largely are funding the airport rebuild — and other airlines about the problem. He said they OK'd buying the security machines to keep the project on schedule.

"The airlines are supportive because there just isn't a choice," he said.

Delta has run into similar problems in other airports, said Wyatt, and has been in the process of buying new security systems in several terminals nationwide to help improve its service.

Airport board members asked if they, the city or others could help lobby Congress for money and help. Wyatt said national airport organizations already have been pushing hard. "I don't think lack of lobbying is the problem," he said, pointing instead to tight budgets.

Wyatt predicts that "airports and airlines are going to continue with their more direct financial responsibility for these types of activities."

Airlines believe they already are doing that through hefty federal taxes they and passengers pay, Wyatt said. "As with all other taxes, half of it goes to the intended purpose and half of it goes to pay the national debt."

The quicker security lines — even if they come at an unexpected cost — were among pleasant surprises passengers may see at the new airport, the advisory board was told in reports Wednesday. Among others mentioned were:

- Parking at the new garage may actually be a bit cheaper because it has twice the capacity as the current one. The airport plans a study before rates are set.
- Each seat in waiting areas will have power plugs, plus two individual armrests (so passengers need not elbow each other to use shared armrests). The new airport will also have 5,000 more seats in waiting areas than the current airport.
- Restrooms for women will have extra facilities after studies show women usually require more time in bathrooms and have longer lines.
- The new parking garage will also have charging outlets for electric cars and capacity to add more over time.

• The airport will have an extra long pickup area reserved for ride-hailing services such as Uber and Lyft.



As we've mentioned before, Salt Lake City International is undergoing a massive \$3.6 billion rebuilding project, with the first phase scheduled for completion in September of next year. But according to the Salt Lake Tribune, city and airport officials have run into a problem when it comes to installing new x-ray screening machines for carry-on bags at TSA security checkpoints: The TSA is responsible for providing the equipment, but the agency has told airport officials it can't afford them. So SLC and airlines serving the airport are planning to chip in the \$10 to \$15 million required for the devices, and then to donate them to TSA, since the agency is legally required to own them. The existing TSA x-ray machines can't be used because plans call for the installation of the new automated screening lanes that allow several passengers to load up screening bins simultaneously.

THREE PROJECTS THAT WILL REDEFINE UTAH

For the past decade, Utah's economy has enjoyed an incredible run. The state has been the envy of the nation in almost every measure when it comes to economic growth and prosperity. Forbes has named Utah the best state for business six times since 2010. So what can Utah do to ensure its place at the pinnacle of economic success for future decades?

Three projects are currently underway: the Salt Lake City International Airport, Utah's Inland Port, and the Point of the Mountain. These projects have the potential to drive Utah's economic success for decades. The airport project has already begun in earnest, while the others will begin to ramp er the next couple of years.

where I sit in the Governor's Office of Economic Development, here's a look at what these ational projects mean for Utah's economic future—for your children, grandchildren, and mine.

...E NEW SALT LAKE CITY AIRPORT

The Salt Lake City International Airport is undergoing a self-funded \$3.6 billion reconstruction with new, state-of-the-art terminals opening over a four-year period, beginning next year. The new airport will have one large, central terminal, and two linear concourses connected by a passenger tunnel. This project will meet Salt Lake City's aviation needs for future decades while creating more than 24,000 jobs and generating more than \$1 billion in wages over the construction period. When completed, the end result will be the country's most modern, technologically advanced airport—a beautiful, gleaming air transportation hub like no other.

The new terminals will include many features to enhance a visitor's experience, including 23 popular local restaurants that will serve their fare at the same prices charged in the city. There will also be a large lounge where families and groups can comfortably gather to greet passengers, including returning missionaries.

The airport reconstruction is being funded without taxpayer funds. The Airport Board set aside money for many years to help pay for the airport updates and renovation. It's remarkable and noteworthy that the Salt Lake City International Airport has operated in the black, without debt for many years.

Other funding sources include bonds, passenger facility charges, federal grants, rental car facility charges, and airport cash.

INLAND PORT

Salt Lake City has a unique economic developmental asset: a large amount of undeveloped land adjacent to North America's 23rd busiest airport. The area, known as Utah's Inland Port, consists of 16,000 acres, including 11,000 acres of developable land. Not only is the land proximate to the airport, but it's also located next to two major interstate freeways and a major rail route.

In 2018, the Utah State Legislature passed legislation creating the Inland Port Authority, placing the developable land in the city's northwest quadrant, under its jurisdiction. The Authority has spent the ear organizing, identifying, and honing the vision for the project.

the details of the port's functionality are still being worked out and a public outreach initiative is way, the overall concept is that an existing business or new endeavor interested in transporting lational goods will have easier access to transportation and customs clearance as well as other stages. Manufacturers who need access to better distribution services have the opportunity to locate in or near the Port.

Another large advantage for the Port is its location inside a Federal Opportunity Zone, meaning many projects inside the Port will be eligible for investment from tax-advantaged Opportunity Funds. It's conceivable that tens, if not hundreds of millions of private dollars could flow into Salt Lake Valley's northwest quadrant to help stimulate and facilitate growth in the area.

The 2019 Utah State Legislature passed a bill which potentially allows the creation of inland port satellite locations throughout the state. The satellites will allow businesses to take advantage of the services offered by the Port without requiring the products to be shipped to Salt Lake City.

Utah exports \$12 billion in goods annually. The inland port is a strategic economic development opportunity to further differentiate Utah from competitive markets and grow the state's exports and economy.

POINT OF THE MOUNTAIN

Because houses began to encroach upon it, the Utah State Penitentiary was moved from Sugar House Park to the south end of the Salt Lake Valley in 1951. Six decades later, residential and commercial development once again have encroached on the prison, leaving legislators to move the prison to Salt Lake City's northwest quadrant.

Located just off of Interstate-15 in Draper, the current 700-acre prison site is in the Silicon Slopes northern corridor. Businesses have sprung up around the prison, making that site one of the most attractive pieces of real estate with the most economic potential in Utah. Legislators reasoned that tax advantages from the development of the 700-acre prison site and surrounding areas would be more beneficial to the state than keeping the prison in Draper.

The legislature created the Point of the Mountain Commission and charged it with conducting a study of the area surrounding the prison site. Envision Utah gathered public feedback to assist with the ss. Thousands of Utahns weighed in on the future of the Point of the Mountain via community ngs and online surveys.

receiving feedback from Envision Utah, the legislature created the Point of the Mountain rity, the body that will be charged with planning the development and disposing of the land. The rity is co-chaired by Lt. Gov. Spencer Cox and Rep. Lowry Snow. Efforts are underway to hire the Authority's first executive director, who will manage the day-to-day efforts of the project.

Over the next few years, as the prison is moved to its new location and the Authority determines how best to develop the Draper land, construction will begin on the 700-acre site. Envision Utah's study pointed out that development of transportation infrastructure will be key to allowing the Point of the Mountain to become the economic hub it's expected to be.

LET'S GET IT RIGHT

These three megaprojects have the potential to drive Utah's economy for many decades to come. The fact that all three are happening at about the same time is serendipitous and provides a great sense of responsibility to "get it right" for future generations. This is our one chance to be innovative and plan appropriately for decades to come. It's a good thing collaboration is Utah's secret sauce. We're going to need an extra helping of it.

A new Delta Sky Club opened at Austin-Bergstrom International Airport on May 21.

The 836 sqm Delta Sky Club is located on the mezzanine level of the Barbara Jordan Terminal and features a sky deck, full-service bar serving seasonal cocktails and beers from around Texas, local artwork and seating areas with WiFi and power outlets.

The Club is situated within the Austin airport's newly expanded concourse, from which Delta now operates. The \$350m (R5bn) concourse was completed earlier this year and added nine new gates and nearly 15 790 sqm to the terminal, which features a multilevel design with new restaurants and retail outlets.

Delta will debut a new Club at the Louis Armstrong New Orleans International Airport and several upgrades to seats and a redesigned food and bar experience at the John F. Kennedy International Airport Terminal 4 Club.

Utah again ranks No. 2 nationally for job creation, while unemployment rate is at low 2.9%

As Utah's economy continues to flourish, it again ranked No. 2 among the states for job growth in the yearlong period ending April 30, according to federal data released Friday.

The number of jobs in the state grew by 3% in that period, behind only Nevada's 3.6% growth, according to the U.S. Bureau of Labor Statistics.

"Utah's combination of strong job growth and markedly low unemployment mirrors the robust economic climate last seen in 2007," said Mark Knold, senior economist at the Utah Department of Workforce Services.

He added that it may offer a great gift to students now graduating.

"Given these conditions," he said, "this is the most favorable Utah job market in 12 years for college and high school graduates to be seeking employment."

Utah added 45,600 jobs in the 12-month period ending April 30, according to the new federal data. It said 1.55 million people were employed in the state.

All 10 of the private sector industry groups in Utah measured by government surveys posted net job increases in April.

The largest private sector employment increases were in leisure and hospitality (9,000 jobs); trade, transportation and utilities (7,900 jobs); and education and health services (6,900 jobs). The fastest employment growth occurred in information (6.2%); leisure and hospitality (6%); and manufacturing (4.6%).

Also, new federal data showed that Utah's unemployment rate in April was 2.9%, well below the national average of 3.6%.

Vermont had the nation's lowest unemployment rate at 2.2%, while Alaska had the highest at 6.5%.

Utah's unemployment rate is so low that many employers have said it is difficult to find workers.

For example, this week Bill Wyatt, executive director of the Salt Lake City International Airport, told its advisory board that the \$3.6 billion project to rebuild the facility would love to hire more construction workers but simply cannot find them. "I have been struck by how challenging the labor market is."

CAN YOU GIVE US A BRIEF OVERVIEW OF THE STATE OF TRAVEL AND TOURISM IN UTAH?

Vicki Varela | Director | Utah Office of Tourism

Last year, tourists spent \$9.2 billion in the state, and that translated into \$1.3 billion in state and local tax revenues. That's money that Utah households would've had to generate in some other way, if not for the \$1.3 billion that tourism is putting on the table. The household relief of that is \$1,375. Every household would have to have paid that much in additional taxes if not for tourists.

Joel Racker | President & CEO | Explore Utah Valley

We're seeing something similar down in Utah Valley. Our occupancy was down almost three percentage points, but we were up nine percent in rooms. So we're seeing a lot of hotel growth, and a lot of that is around the business travel side.

Greg Ross | Vice President | Hess Corporate Travel

Business travel tends to be a leading economic indicator. People tend to invest in travel [when they] are optimistic about the future, so that is a bit of an indication that things are good. We had our best year ever last year. And all indications are that we're already off to a really strong growth year this year as well.

Ryan Starks | Executive Director | Heber Valley Tourism & Economic Development

In Wasatch County, I think optimism is as high as it's ever been, and we have two specific developments which I think are telling of that level of optimism. The first is MayFlower Mountain Resort by the Excel Development Company near the Jordanelle. 388 new rooms with 100 of those being dedicated to service men and women. We also have another development in Black Rock Ridge.

It'll have three ice rinks in it, with a niche specialty [to attract] the professional hockey players for training.

And what we're hearing from our industry is that they're waging on continued strength within the tourism economy, because our groups are not just coming one or two years out, but they're coming four and five years out.

Matt Wirthlin | Partner | Holland & Hart

Multi-family development is as strong as it's ever been. They can't build fast enough. The demand is much higher than the growth. So I think it's optimistic with some caution built in, knowing that things will slow down at some point.

Braden Moore | Director of Development | Big-D Construction

Here in Utah, we're fortunate to have some big, mega projects. Obviously, the Salt Lake City airport was huge for everyone in this room. The biggest problem we're having is finding people, because there are some big projects and a lot of outside capital are bringing in some mega projects into the state. So it's huge for Utah. It's huge for our employee base here, but we have a struggle in that we don't have enough people to build everything that's coming in.

Nancy Volmer | Director of Communications & Marketing | SLC International Airport

We saw 25 million plus passengers this past year, so that's a 5.6 percent growth. And the airport's built for 10 million passengers, so we are seeing more than double that. When you go out there and there's a lot of congestion, there's a reason why. Salt Lake City ranks as the third-fastest growing large hub airport in domestic passengers in the country, and we're the fourth-largest hub for Delta Airlines. We just can't get this new airport on board soon enough.

According to <u>CompareCards.com</u>, the airport comes in second in the U.S. for not having delays, Honolulu comes in first.

Is SLC Airport prepared for a fiery crash?

After 41 people died on a Moscow tarmac, officials here say they are prepared.

SALT LAKE CITY (ABC4 News) - Forty-one people died in a literal ball of fire Sunday after what officials are calling a botched landing in Moscow.

Salt Lake City Fire Captain Brandon Turman explained that the plane landed minutes after takeoff and bounced coming down.

"Aircraft, they're designed to take off with a full load of fuel, but they're not designed to land with that fuel. Those impacts compromised the fuel cells and that's why it was a fireball going down the runway," said Turman.

Investigators are still learning why the pilot landed so recklessly, but here in Salt Lake City, Station 12 is charged with making sure a similar tragedy can't become so deadly.

Turman said, "The biggest role that we fulfill here is to provide aircraft rescue firefighting for all of the daily departures and arrivals at the airport."

FAA regulations mandate that fire crews be able to get to any incident and be spraying within three minutes of an emergency call.

Their crews work with special training and specialized vehicles called crash trucks. These trucks carry six times the amount of water and foam as a normal fire engine because there are no hydrants on the tarmac. They also come with infrared detection and a hole-punching nozzle to spray inside the aircraft.

The captain says most of their calls are for general medical incidents at the airport, but they have to be ready for the worst.



Study: Salt Lake County in top 25 places at risk of measles outbreaks in 2019

May 10,2019

SALT LAKE CITY — A new study ranks Salt Lake County as one of the top 25 places across the country to have a measles outbreak in 2019.

The Utah Department of Health told KSL they have been tracking the virus.

"(The ranking is) not surprising because we do track our vaccinations among our communities and we knew this was coming," said Dr. Angela Dunn, the state's epidemiologist with the Utah Health Department. "We are seeing cases of mumps...[and] if we have mumps, measles will be right around the corner."

The study, which was released by the health journal "The Lancet Infectious Diseases," a team of researchers ranked 25 counties across the country. Salt Lake County was number 19 on that list.

The main reason is because Salt Lake has an international airport that is the 23rd busiest airport in North America and the 85th busiest in the world.

"A common way that people get exposed to measles is from international travelers and we've got this great international airport here in Salt Lake County," said Dunn. "That does put us at a higher risk of having a measles

outbreak just because of exposure."

She also says there is no reason for panic or concern about traveling.

Dunn says the vaccination rate across the state is actually very high in the 96 and 97 percentile. There are some areas that are not as high, and she said that could be a problem.

"We do have these small pockets [in communities] that have low immunization rates that puts them at a higher risk for a measles outbreak," she said. "The basics: wash your hands, don't touch your face, and just that hand face hygiene is what is going to keep a lot of people safe and healthy."

The last time Utah had actual measles cases was in 2017 when three broke out. Currently, Utah has 15 cases of mumps.

Nancy Volmer, the spokesperson for the Salt Lake City International Airport, said they do have plans and procedures in place should a passenger be detected with an infectious disease.

"We are always doing exercises to visit various possibilities at the airport and this is just one of those that we have plans in place to address," said Volmer.
