Mayor Biskupski Selects Bill Wyatt to Lead Salt Lake City Department of Airports

Mayor Jackie Biskupski appointed Bill Wyatt to the post of Executive Director of the Salt Lake City Department of Airports on Oct. 12.

Bill comes to SLC with extensive experience in both the public and private sectors, most notably in his role as CEO of the Port of Portland. For the past 17 years, Bill oversaw the complex logistics of day-to-day operations of all Port activities as customer-focused leader. He handled \$2 billion in capital construction projects, managed a \$330 million annual operating budget with fiscal prudence, developed a workforce of 800 employees, and maintained excellent relationships with many stakeholders, including elected officials, community partners, Delta, TSA, and more.

The Department of Airports oversees a portfolio of three airports, including Salt Lake City International Airport, South Valley Regional Airport in West Jordan, and Tooele Valley Airport in Erda, Utah. As director, Bill will manage operations including over 500 employees, 1,000 contracts, and an annual budget of \$367 million.

Winter Hangar Prohibitions

With winter upon us, the Salt Lake City Department of Airports (SLCDA) would like to remind tenants of the required and prohibited operation procedures in hangars.

- Refueling aircraft in hangars, including shade hangars, is prohibited. Tenants
 wishing to self-fuel their aircraft must obtain a self-fuel permit from airport
 operations. Aircraft can be no closer than 25 feet to their hangar when
 fueling.
- Starting aircraft in and/or taxing into and out of hangars is prohibited.
 Aircraft need to be pushed out of hangars to the taxi-lane centerline prior to engine start.
- Power run-ups are only authorized in designated run up area near the ends of each runway.
- Enclosed T-hangars are required to have fully charged and properly inspected fire extinguishers accessible to the front hangar door at all times. Fire extinguishers must display inspection stickers from a competent authority authorized to meet requirements under Utah code.
- Only electric engine heaters are authorized for use when placed at least 16 inches above the hangar floor and are electrically connected with a minimum of a 12-gauge extension cord.
- Open flame space heaters are prohibited at all times. Electric space heaters can be used when fully attended and when connected to a power source with a minimum of a 12-gauge extension cord.
- Vehicles need to be parked inside the tenants leased hangar or in the parking lot while the tenant is out flying.
- Only non-corrosive ice melt can be used on the airport.
