FYI...attached are the upcoming Automated Vehicle Identification (AVI) rates which will go into effect July 1, 2024. You will notice two things. First, all the rates decreased for the upcoming fiscal year, and second, the addition of Terminal Dwell Rates. Terminal Dwell rates only apply to the commercial curb areas after you enter Booth 10. For vehicles that stage on the commercial curb for long periods of time, these rates will apply. Please note, those companies who are under contract with the airport will be exempt from the Terminal Dwell Rates.

Please note the following:

1. <u>AVI Rates:</u> The automated vehicle identification (AVI) rates (Including Terminal Dwell) for airport ground transportation (GT) fees effective July 1, 2024, are set forth in the table below. The goal of the program, approved by the City Council, is for the commercial fees to fully fund the cost of the GT program.

- 2. <u>Payment Due Date</u>: The due date for payment of AVI invoices will be the 16th day of the month following the month the trip charges are incurred. For example, June's trip charges will be billed on July 1st and due July 15th.
- 3. <u>Collection Procedures</u>: If payment is not received by the 16th, collection procedures will begin on the 17th day of the month.
- 4. <u>Inactivation of AVI Tags</u>: After 30 days of non-payment all AVI tags held by the company will be deactivated until the account is paid in full. Per 5.71.010, companies may not operate within the corporate limits of Salt Lake City without active and/or valid AVI tags. AVI tags may be reactivated when all fees are paid, and the company obtains written authorization from the Department of Airports to operate as an authorized GT Business.
- 5. <u>Sold or Retired Vehicles</u>: Within 72 hours after a company vehicle is sold or retired from service, all inspection seals and AVI tags must be returned to the Airport. Failure to return seals and/or tags will result in a \$500 fee for each tag and/or seal.
